260ft Passenger Cruise Vessel For Sale. modern looking vessel that has a sleek appearance of an oversized yacht. She has 148 passengers berths in 69 cabins (138 PAX max sailing). The vessel does have a well equipped galley with ample dry refrigerated and freezer storage. In addition, the vessel has a full laundry facility to handle its needs. As a dockside accommodations vessel she has ample berthing facility for up to 175 pax plus service crew classified +A1 Passenger Vessel +AMS by the American Bureau of Shipping(expired) and was certified for coastwise and international service by the United States Coast Guard(expired). The ship carries a Passenger Ship Safety Certificate issued under the provisions of the International Convention for the Safety of Life at Sea (SOLAS), and a Certificate of Sanitary Construction issued by the FDA (expired) . Vessel was drydocked in Dec 2017 and after further repairs afloat and had only a few minor works remaining towards COI renewal at that time. Vessel was dry-docked around March-April 2020 with considerable hull upgrades resulting in a renewed COI issued by the USCG which is valid till 2025 (pending annual renewals which have not been done). Vessel at one time had Coastwise & Great Lakes routes up to 20 miles offshore. Owners are inviting new rounds of outright cash offers (no subjects of any kind) on strict "as is/where is" terms basis delivery with certificates -either valid or expired- "as on board." Price reflected on this spec sheet is strictly as a "test" offer and not based on any price given by sellers.
